Inmate Arias was in programs to do a legal phone call. [REDACTED] told inmate Arias I said no and she then stated to him, "I knew she would say no. She's a cock blocker." After inmate Arias' legal call was complete I asked her what exactly she said to [REDACTED]. At first she did not want to admit what she said but then finally admitted to calling me a "cock blocker." I explained to her that her statement was completely inappropriate and could be taken as a sexual reference. She told me that she did not know that word to mean anything sexual and I could look up the phrase on urban dictionary because that would show it means to "stonewall someone."
